From Hwy 1 North: Take the Nashua rd. exit (just South of the Castroville exit). You will circle back over the highway and continue on Nashua past Pezzini Farms vegetable stand. Nashua rd. will soon blend into Cooper rd. which you will stay on until you reach Blanco. Go left on Blanco and right on Hwy 68/Monterey Hwy to the Portola exit. Go left on Portola and your first right is Toro Hills Ave.

From Hwy 101 North: As you approach Salinas, take the Laurel exit. Go right on Laurel and an immediate left on Davis road. Take Davis rd to Blanco and go left on Blanco. After several lights you will turn right on Hwy 68/Monterey Hwy. Go towards Monterey until you reach the Portola exit. Take this exit, go left on Portola and right on Toro Hills ave.

From Monterey: Take Hwy 68 towards Salinas to the Portola exit. Take the Portola exit and stay on Portola (straight) until Toro Hills Ave., then go right.

From South of Salinas: Take the Spreckles exit. Go through Spreckles and continue West to Hwy 68. On Hwy 68 go towards Monterey until you reach the Portola exit. Go left on Portola and your first right is Toro Hills Ave.
